## NOTICE TO PERSONS INTENDING TO BECOME A MEMBER OF N.Q. CO-OP LTD

<u>Inspection of Documents:</u> Notice is hereby given to persons intending to become a member of the Cooperative that the following documents are available for inspection at the registered office and at each other office of the Cooperative during displayed trading hours.

- A consolidated copy of the rules of the Cooperative, and
- A copy of the last Annual Report of the Cooperative under Section 242 of the Cooperatives Act 1997
- A copy of all special resolutions other than those altering the rules.

Active Membership Requirements: A member shall purchase goods and/or services from the Cooperative to the value of a minimum of \$10,000 per year to establish active membership of the Cooperative. All members of a cooperative must be active members. A member who fails to be or stops being an active member must, under the Act, have their shareholding cancelled and, subject to Section 132 of the Act, their shares forfeited.

Qualification for Membership: Every member must hold at least 1,500 shares.

**Application Form:** To become a member you must complete and "Application for Membership" form.

<u>Cost of Membership:</u> To become a member you must pay a deposit of \$1,000, which entitles you to 500 shares at \$2.00 per share. No entry fees or regular subscriptions are applicable. A copy of the rules of the Cooperative may be purchased for \$25.00. The balance of 1,000 shares at \$2.00 each must be paid on calls as approved by the Board.

<u>Benefits & Conditions of Membership:</u> Completion of the "Application for Membership" form, and payment of \$1,000 deposit.

If your application is approved you should receive your letter confirming same.

If you decide to surrender your shares, or move to a new address, please advise Support Office in Mareeba, and the appropriate paperwork will be forwarded to you.
